

COVID-19 防疫期間—個人資料蒐集、處理及利用之告知暨同意書

COVID-19 Prevention Related – Protection of Personal Data Announcement

基於防疫需求，中國鋼鐵股份有限公司(下稱中鋼公司)為了蒐集、處理及利用您所提供或未來提供的個人資料(下稱個資)，謹先告知下列事項：

According to the COVID-19 prevention, your personal data will be collected processed and used by the CSC, the announcement as follows:

Period of use the personal data: 28 days since the collection day.

4. 利用地區：中華民國。

Area of use the personal data: Taiwan

5. 利用者：中鋼公司、衛生主管機關。

User of personal data: CSC and Official Health Agency in Taiwan.

6. 利用方式：為防堵疫情而有必要時，得提供衛生主管機關依傳染病防治法等規定進行疫情調查及聯繫使用。

For the COVID-19 prevention, the information you provide herein will be provided for Official Health Agency in necessary.

7. 您得以書面主張下列權利：

查詢或請求閱覽；請求製給複製本；請求補充或更正；請求停止蒐集、處理或運用；請求刪除。

You may have the following rights regarding your relevant personal data: the right to request access to the collected personal data, request a photocopy of the collected personal data, request supplement or rectification of inaccuracies in the collected personal data, request us to cease the personal data collection, processing or use, or delete the collected personal data.
